

JOURNAL OF EAST ASIAN LIBRARIES PUBLICATION AGREEMENT

This Agreement, effective _____, 200____ entered into between *Journal of East Asian Libraries* (hereinafter "Publisher") and _____ ("Author(s)"). Both the Publisher and the Author(s) may hereafter be referred to individually as a "Party" and jointly as the "Parties." Publisher is pleased to undertake the publication in *Journal of East Asian Libraries* ("JEAL") of manuscript number _____ entitled ("Contribution"):

In consideration of the promises and mutual covenants contained in this Agreement the Parties agree as follows:

1. Grant of Rights and Agreement to Publish

The Author(s) hereby grant(s) to the Publisher a non-exclusive license to publish, produce, transform, derive, perform, display, reproduce, distribute, or otherwise use in all languages, in journal, book format, or in any other form, format, means, or technology, whether known or not yet discovered, including but not limited to print, electronic, and the Internet in the United States and in any foreign countries, the above-named Contribution or any portion thereof.

Subject to the terms and conditions herein, Publisher hereby agrees to publish the Contribution as soon as is practicable. In no event shall Publisher be obligated to publish a Contribution, which in its opinion violates a common law or statutory copyright law, violates the right of privacy of any person, or contains libelous or obscene matter.

2. Editorial Processing

The Author(s) will submit Contribution in accordance with the submission procedures set forth in the *JEAL* and as found in the section "Notes for Contributors to JEAL" of the Council on East Asian Libraries Committee on Publications Home Page:

The satisfactory manuscript delivered to and accepted by Publisher will be subject to modifications by Publisher's editorial staff. Certain outside readers as Publisher may appoint any members of Publisher's editorial staff as assigned, who shall make comments on the changes or modifications that they deem necessary to complete or enhance the Contribution. These may include, but are not limited to, alterations in layout, format, punctuation, spelling, and style. In any event, Publisher will make the final determination as to the tone, quality, and language of the published Contribution. Any modifications by Publisher's editorial staff are to be approved by Author(s). In the event that Author(s) and Publisher's editorial staff cannot agree upon modifications, Publisher may, at its option, terminate this Agreement.

The Author(s) of original articles (not committee reports or news items) will be given the opportunity to read and correct proofs of the edited manuscript, but if these are not returned to the Journal Editor by the date specified by the Editor, then production and publication may proceed without the Author(s)' corrections.

3. Author's Warranty

The Author(s) represents that he/she is the sole proprietor of the Contribution; that it does not infringe any existing copyright or other intellectual property rights; that it has not been nor is being considered for publication elsewhere; and that to the best of his/her knowledge it contains no libelous or other unlawful matter. The Author(s) shall indemnify and hold harmless the Publisher against any and all claims (including claims by third parties), disputes, litigation, arbitrations, settlements, damages, losses, attorneys' fees, expenses, and liabilities arising from or relating to any proceedings brought against the Publisher by reason of any violation of any proprietary right, intellectual property right, or copyright, or any unlawful matter contained in the Contribution.

If previously copyrighted material is included in the Contribution, the Author(s) hereby confirms that permission of its reuse has been received from the original copyright holder. A copy of each permission obtained shall be submitted with the manuscript. The publication(s) in which the copyrighted material(s) appear(s) should be listed in the Literature Cited section of the Contribution. In each figure, illustration, table or block of text that uses previously copyrighted material, a citation should appear.

4. Copyright Ownership

The Author(s) shall retain copyright ownership to the Contribution and shall have the right to quote from, reprint, translate and reproduce the Contribution in any book or article he/she may later write. If the Author(s) reproduce a portion of the Contribution in a book or article, in original or modified form, he/she shall cite the Contribution as printed in JEAL as the source.

5. Entire Agreement

This Agreement constitutes the entire agreement and understanding between the parties and supersedes all prior agreements and understandings regarding the same. No modification or claimed waiver of any of the provisions of this Agreement shall be valid unless in writing and signed by an authorized representative of the party against whom such modification or waiver is sought to be enforced.

6. Governing Law

This Agreement shall be interpreted and construed in accordance with the laws of the State of Utah. Venue for any legal disputes shall be in Utah County, Utah. However, this restriction shall not be binding on Publisher with respect to any claim or cause of action for infringement of its copyrights or other intellectual property, and Publisher may file any action in, and may seek relief from, any court of competent jurisdiction for any such claim or cause of action.
